It was unclear who the personnel were at the meeting and it seemed to be a 'done deal'. He feels that their concerns were not addressed satisfactorily.

Cllr Windass explained that the meeting in Harrogate was convened to determine officer recommendation for approval. If it there were objections there would be an appeal. If it was approved the only course of action would be an expensive judicial review. The planning was recommended for approval by HBC.

Cllr Fearnside stated Langthorpe Parish Council had objected to the application.

HBC planning to be contacted to be asked why this was passed when there were significant objections ie building in front of the building line. Clerk to write to HBC Planning department. <u>Action: Clerk</u>

- 5) Matters Arising (not covered elsewhere)
  - a) Harrogate Borough Council (HBC) Council tax will rise as central government council tax support grant has been reduced by 24%. HBC will increase council tax by 1.99%. Savings will be made from the premises relocation.
  - b) North Yorkshire County Council (NYCC) Also reported a rise on council tax by 3.99% 2% of this increase is due to adult social care responsibilities. Cllr Gill reported that Lowfields Lane gullies blocked. It was noted that reports cannot be viewed under new system for reporting highways faults. Cllr Windass will investigate and ask why at upcoming councillors surgery. Cllr Brown congratulated the emergency committee for work during floods.

Before Cllrs Windass and Brown departed, Cllr Collins informed the council that Langthorpe resident Margaret Dawson has been awarded an MBE. The Council will send a letter of congratulations include county and district councillors.

  - a) To receive information regarding changes to the External Audit Regime Local councils have been given the choice to opt out of the new sector led body audit regime. This regime is laid out by the recently created Smaller Authorities' Audit Appointment Ltd which will take over the appointment of external auditors and deal with the setting of audit fees. The company has been established on behalf of the department for Communities and Local Government (DCLG) by the National Association of Local Councils (NALC), the Society of Local Council Clerks (SLCC) and the Association of Drainage Authorities (ADA). The council must decide to opt in or out of the Sector Led Body by 31 March 2016. The clerk recommends that the Council remains opted in to the Sector Led Body on the grounds that although smaller authorities (under £25,000) don't have to submit an external audit return in 2017, an auditor still needs to be appointed. The Sector Led Body has buying power that individual councils do not have so can boast lower fees for external audit than if a council finds their own auditor. RESOLUTION The Council agree to remain opted in to the Sector Led Body Proposed: D Fearnside; seconded M Fisher. A in favour. No further action required.
