Report on Yorkshire Water Visit

Following a meeting with Yorkshire Water, Cllr Collins reported the water authority are satisfied the increase in demand will be met. All manholes are currently clear.

Highways

The Parish Council still require clarification as to which roads are classified as Category 6. Cllr Windass suggested Richard Flinton was contacted under the 'Freedom of Information Act'.

Cllr Windass reported that Thornton Bridge would be closed for six weeks, and controlled by traffic lights for six weeks thereafter.

The damaged signpost on the roundabout has been removed whilst it is repaired.

Cllr Windass reported that Area 6 Highways are not responsible for removing the advertising banners on the roundabout.

Cllr Gill reported the property owner of Lowfield Grange will maintain the road from the property up to the Council gully. He again expressed his concern over the poor road surface.

Cllr Collins has had no response to his enquiry regarding the road markings carried out on Skelton road last August.

It was reported better drainage was required on the bend on Skelton Road to avoid flooding and that Stephen Knowles was waiting for some pipe to assist in repairing it.

Cottages

Cllr Collins has received a quotation to carry out repairs to the cottages as recommended at the last annual inspection. All members were in agreement that the work should go ahead.
