Member of public present was concerned about the potential traffic coming out from the development onto Leeming Lane. She was also concerned about the welfare of the bats and owls nesting in the poultry farm. The Council assured the lady present that developers have a statutory responsibility to take nesting/roosting bats in to consideration but recommended that the resident contacted Harrogate Borough Council directly regarding these concerns.

Cllr Flynn noted current speeding issues on Leeming Lane which are being made worse by building work at Hockley Croft. He expressed concern that this new proposed development would add further to the problem.

C The Parish Council does not object to or support the application but wishes to seek safeguards:

- The Council is concerned about potential traffic problems caused by the egress of this development onto Leeming Lane where speeding is already a problem.
- The Council also requests an ecological survey to be carried out to protect the bats and owls that currently reside in the buildings.
- The Council requests adequate provision is made for sewerage disposal as the system is currently over-stretched.
- The Council noted a discrepancy in plans between the site plan and the street scene where plot no. 30 shown as mirror image.
